The Board will continue its review of Chuck Joseph's (CJPM Development LLC) request that the Board endorse a Citizen's Petition asking Town Meeting to authorize the Board of Selectmen to petition the General Court for passage of a special law granting an additional package license to CJPM Development LLC for the sale of all alcoholic beverages not to be drunk on the premises at 22 South Street. Town counsel confirms that special legislation mechanism provides for licenses above and beyond the number of licenses otherwise authorized to be granted to the Town under the provisions of Section 17 of Chapter 139 of the General Laws.

8. REQUEST TO TERMINATE TAX INCREMENT FINANCE (TIF) AGREEMENT WITH BARRY CONTROLS, 82 SOUTH STREET

On March 27, 2012 Massachusetts Economic Assistance Coordinating Council (EACC) decertified Barry Controls from the state investment tax credit for its failing to meet job creation guidelines. Town staff and town counsel recommend the board terminate the TIF Agreement with Barry Controls because: (i) on March 9, 2012 the state classified Barry Controls as a manufacturing cooperation; (ii) Barry Controls never utilized the real property tax available under TIF; and (iii) the company does not plan to expand its operations in Hopkinton in the near future. The manufacturing corporation classification exempts Barry Controls from local property liability.
